Terms and Conditions

1. Promoter

2. Promotion Period

The promotion starts on 01 November 2025 and ends on 31 January 2026 (“Promotion Period”).

3. Eligibility

- Entry is open to Australian residents only 18 years and over.
- Employees of the Promoter and their immediate families are not eligible to enter.

4. How to Enter

To enter, participants must:

- Purchase EnviroSafe Fly Trap, EnviroSafe Jumbo Fly Trap, and/or EnviroSafe Alfresco Fly Trap from any official retailer in Australia during the Promotion Period.
- Visit: envirosafeaustralia.com.au/competition
- Complete the online giveaway competition entry form; and
- Upload a photo of the purchase receipt as proof of purchase.
- The purchase receipt must clearly display the following to qualify as a valid entry:
 - i. The name and address of the retailer
 - ii. The retailer’s ABN or ACN
 - iii. The transaction date
 - iv. The product description or item/s purchased
 - v. The purchase price of the item/s purchased

Multiple entries are permitted, but:

- Each entry must be supported by a separate purchase receipt.
- The same receipt cannot be used for more than one entry. Duplicate entries with the same receipt will be counted as one valid entry only.
